## Chairman's message

Season's Greetings to all Group employees and welcome to our first ever Foundation newsletter. In the spirit of the season, we'd like to share a few snippets of our corporate philanthropy.



The Foundation's social impact is made on two fronts: Our support for civil society organisations in T&T, and through our flagship regional programme - the Anthony N Sabga Awards, Caribbean Excellence.

This year, as we've done for over 20 years, we provided funding to a range of non-profit and community-based organisations for specific initiatives. We also produced a series of videos on seven of those beneficiaries, because we believe in the importance of highlighting their work to a public longing for good news. This was a big year for the Anthony N Sabga Awards as we celebrated the 20th anniversary of the founding of the Caribbean's most prestigious corporate awards programme. Our laureates (awardees) for 2025 were jazz trumpeter Etienne Charles of T&T, agri-entrepreneur Rachel Renie-Gonzales, also of T&T, family therapist Dr Ayodele Dalgety-Dean of Guyana, and cancer researcher Dr Simone Badal of Jamaica. Each received TT\$500,000 or the local currency equivalent at a gala event at the Hyatt Trinidad in June.

Since 2005, we've awarded a total of 66 mid-career professionals for excellence in human endeavour that uplifts the region, presenting them with over TT\$32 million in funding. Not only does that money spur more work, but our laureates' visibility also sets the standard for a new generation of Caribbean Excellence. And that is why we're happy to tell their stories.

As we continue to align the ANSA McAL Foundation with the Group's sustainability objectives, we intend to produce greater insight into our social impact through annual reporting. Our commitment to increased accountability comes as the Group focuses on playing an even greater role in building Caribbean society through its Purpose of "Inspiring Better Choices for a Better World."

May you all enjoy a wonderful Christmas with family and friends. At the Foundation, we too are looking forward to our share of Christmas fare, and a little downtime, even as we anticipate the choices we'll make towards creating a better Caribbean in 2026.
